NAME OF THE TRUST:


1. The Trust hereby declared and constituted is a Public Charitable Trust and shall be carried on under the name and style of "DR. S.H. IBRAHIM EDUCATIONAL TRUST" (hereinafter called and referred to as "THE TRUST") serving the needs of all places in India.
2. The Registered Office of Trust shall be situated at No. 23/1, Patel Street, Iyyappa Nagar, K.K. Nagar Post, Trichy - 620 021 and/or other place or places as the Trustees agree upon from time to time.

OBJECTS AND PURPOSES OF THE TRUST:

- a. to establish, take over or acquire and maintain, manage and conduct schools, residential schools, colleges, University, Virtual University, training institutions, study centres, study groups and other educational institutions, hostels or libraries for imparting and advancement of general, technical, sports, medical, professional, industrial or other means of education and training for the utility and welfare of the general public, either for free of cost or at concessional rate;
- b. to establish, maintain, run, improve and develop study centres for universities, institutions or other bodies.
- c. to establish, take over or acquire and maintain, manage and control hospitals, clinics, dispensaries, laboratories and medical research centres and to provide medicine, medical and surgical aid and advice freely to the poor and destitutes;
- d. to promote employment among unemployed youth, women and men through government agencies and state financial institutions by encouraging them to gain access to credits, to set up income generating projects which will have an impact on the economic growth;
- e. to establish choultries, rest houses, orphanages, poor homes for the benefit of poor, destitutes and the aged.

- f. to afford relief to people in distress and poverty and give food and clothing or money or alms to the poor;
- g. to award scholarships or stipends or interest free / concessional rate of interest loans in India to students and sports persons to enable them to continue their studies and / or sports activities and to award prizes to students for proficiency in any subject or language or sports or humanities;
- h. to help the poor, downtrodden, needy students and weaker segment of the society to pursue education; to act as catalyst in promoting quality oriented value based higher education; to establish training centers, model production centers and industrial units to facilitate practical training to students of Arts and Science, Engineering, Applied Science, Medical Sciences etc., and to provide adequate training and experience in production, business, financial, HRD, marketing and industrial management which is basic requirement for seeking job either in public or private sector undertaking in the country and to create employment opportunities among the youths;
- i. to establish, takeover or acquire and maintain, run and/or render financial assistance to any nursing homes, dispensaries, educational institutions libraries, homes and schools for the old, disabled, handicapped and blind persons and institutions of medical research or education and surgical treatment, care, cure, recuperation and other advantages to alleviate the sufferings of the handicapped, aged, poor, etc.;
- j. recruit, train and to provide or to assist in recruitment and training educational and other staff for any such institutions;
- k. to encourage the study of sport, philosophy, civilizations, cultures, spirituality, doctrine and various languages;
- l. to hold conferences, meetings and discussions in respect of above subjects;
- m. to publish newspapers or periodicals in any languages of educational, medical and/or social nature; to start and publish books, journals and other materials useful to Arts, Science and Technology; to promote research and development activities in various disciplines of Science and Engineering;
- n. to acquire, construct and maintain buildings to advance the objects mentioned above;

- q. to hold, arrange and organize meetings, lectures, talks, discussions, seminars, symposia, conferences, competitions, research and study visits, tours, excursions, exhibitions, debates, cinema, Audio-visual Programmes, the artistic performances, and other cultural activities, social functions, sports & games.
- r. to acquire, purchase, receive, construct, maintain and manage community halls, halls for prayer, Lecture, Libraries, discourses and debate for advancement of knowledge and giving mental health Peace & Stability.
- s. to Let out halls at the time of idleness (other than that of own use) to others either at free of cost or at Concessional rate of rent for the purposes referred above.
- t. to afford relief to people in distress due to happening of natural calamities;
- u. to save natural resources either directly or through associations.
- v. to do all such other lawful things as are incidental or conducive to the attainment of the objects;

**ADMINISTRATION OF THE TRUST:**

4. The Management of the Trust shall vest in the "THE COUNCIL OF TRUSTEES" consisting of not more than Fifteen but not less than five trustees. The Council of Trustees shall have the full power and authority to administer the Trust, its properties and affairs and to do all acts, deed and things which are calculated to fulfill the performance for which the trust is established. The Council of Trustees shall act through the Chairman-cum-Managing Trustee.

**COUNCIL OF TRUSTEES:**

5. The Council of Trustees of the Trust shall contain the following persons as its first Trustees, who are as under:

- (i) DR. A. NAGOOR GANI, aged about 48 years, son of Mr. S.Allapitchai, residing at No. 23/1, Patel Street, Iyyappa Nagar, K.K. Nagar (Post), Tiruchirappalli - 620 021;
- (ii) Mrs. S.H. ANJITHA, aged about 45 years, wife of DR. A. Nagoor Gani, residing at No. 23/1, Patel Street, Iyyappa Nagar, K.K. Nagar (Post), Tiruchirappalli - 620 021; and
- (iii) Mr. N. MOHAMED FAZIL, aged about 20 years, son of DR. A. Nagoor Gani, residing at No. 23/1, Patel Street, Iyyappa Nagar, K.K. Nagar (Post), Tiruchirappalli - 620 021;

APPOINTMENT OF CHAIRMAN-CUM-MANAGING TRUSTEE:

6. One of the Trustees shall be the Chairman-cum-Managing Trustee; DR. A. NAGOOR GANI, shall be the First Chairman-cum-Managing Trustee who shall hold office during his life time or until he resigns from the office of the Chairman-cum-Managing Trustee, by notice in writing to the other Trustee or Trustees, whichever is earlier.
7. The first Chairman-cum-Managing Trustee or his successor to his office shall be entitled to nominate his successor, to hold the office of the Chairman-cum-Managing Trustee ceasing to be the Chairman-cum-Managing Trustee. The nominated successor shall become the Chairman-cum-Managing Trustee.
8. The Vacancy of the office of the Chairman-cum-Managing Trustee, caused by death or resignation, shall be filled by the Board of Trustees, by electing a member among legal heirs of the deceased Chairman-Cum-Managing Trustee either by unanimous decision or by poll.

APPOINTMENT AND REMOVAL OF TRUSTEES:

9. The Trustees shall have the power to appoint additional Trustees, provided that the total number of Trustees for the time being shall not exceed Fifteen.
10. Vacancies among the Trustees may be filled up by the Trustees, but if consequent upon a vacancy, the numbers of Trustees become less than two, the remaining Trustee shall fill up the vacancy.
11. Each of the Trustees appointed under the provisions of these presents, (including the Chairman-Cum-Managing Trustee) shall hold office during their life or until he/she resigns from the office of the Trustee, by notice in writing to the other Trustee/s, whichever is earlier. In case of death of any of the Trustee, including the Managing Trustee, then their legal heir or legal representative shall be appointed in that vacancy provided the legal heir or legal representative agreed for it.
12. Any Trustee may retire at any time without assigning any reason and without being responsible for any costs occasioned by such retirement.
13. The Chairman Cum-Managing Trustee can remove any trustee at any time at his discretion, if he feels that any of the other trustee's is not functioning properly.

POWER OF TRUSTEES:

14. The Trustees shall have all the powers necessary or incidental for effectually carrying out the objects of the Trust. Subject to the general provisions of the Trust and without prejudice to the


General and specified powers conferred upon the Trustees by the other provisions contained in these presents, the Trustees shall have the following powers also;

- (a) to acquire, purchase, grant, gift, exchange, lease, hire or otherwise, any land, buildings, movables and properties of every other descriptions;
- (b) to sell, mortgage, grant on lease, hire and otherwise alienate any of the properties of the trust;
- (c) to enter into all contracts on behalf of the trust and to rescind them;
- (d) To apply for and borrow money from any scheduled or nationalized bank or from financiers or financial institutions with or without security and to repay the same;
- (e) to open accounts in bank/banks and operate the same;
- (f) to apply the Trust moneys to effectuate one object or some of the objects of the Trust in preference to the other objects;
- (g) to discontinue the application of Trust funds to one object and divert the funds to another object;
- (h) to decide the nature, objects and functions of the institutions to be established by the Trust and to decide whether and if so what existing institution or institutions may be taken over by the Trust or to which financial aid may be given and to act as head of the above referred institutions;
- (i) in case it is decided to render financial or other aid to any institutions including libraries, blood banks, etc., to decide what terms and conditions should be complied with by such institutions;
- (j) to determine the terms and conditions on which any donations, subscriptions, scholarships or prizes are to be given by the Trustees;
- (k) to expend the fund of the Trust in such manner as they shall consider most beneficial for the purposes of Trust;
- (l) to build upon, pull down, rebuild, add to, alter, repair, improve, or dispose off or otherwise deal with any land, building or premises for the use of the Trust;
- (m) to acquire any property in exchange for some other property or partly in such exchange and partly for other considerations;
- (n) to appoint, terminate, suspend or otherwise deal with the staff employed for the administration of the Trust;
- (o) to appear before the courts, tribunals, public officers, etc.



- (p) to invest all the funds of the trust not immediately required for the purposes of the trust in such as it deems fit according to the provisions of the Income-tax Act 1961, which governs the Charitable trust; and
- (q) to carry on or manage any business which is incidental to the objects of the Trust in which the funds of the Trust may be invested.
15. The Trustees shall hold such meetings as may from time to time be necessary, considering any matter connected with the Trust or its affairs or to transact any business of the Trust.
16. The Trustees may make rules for regulating their meeting not being inconsistent with any provisions contained in these presents and they may make rules for passing any resolutions by circulation among the trustees and the Trustees may repeal or alter any rules made in pursuance in this clause.
17. A meeting of the Trustees may be called by any of the Trustee, on not less than three days notice in writing, specifying the date, and hour of such meeting and the nature of the business to be transacted at the meeting and such notice shall be sent by post or delivered to every Trustee. The accidental omission to give notice to or the non-receipt of notice by any Trustee shall not invalidate the proceedings at any such meetings. With the consent of all the Trustees a meeting may be convened by such shorter notices as in such manner as the Trustees may think fit.
18. The Chairman-cum-Managing Trustee shall ordinarily preside over the meetings of the Trustees and if he is not present in any meeting, the other trustees present, may elect from among themselves a trustee to preside over the meeting, but at such meeting, only business relating to routine matters shall be considered whatever be the agenda of which notice is given.
19. All meetings of the Trust shall be held at the registered office of the Trust or the some other place as decided by the trustees.
20. Two Trustees at a meeting shall form a quorum for any meeting of the Trustees.
21. On all important matters and in particular in the matter of investing or exercising the borrowing powers, the decision of the entire council of Trustees at a meeting or by circular resolution shall be necessary.
22. A Trustee who is unable to be present at a meeting of the Trustees may send his views on the agenda in writing and such expression of opinion shall be taken to be his vote on the matter concerned.
23. On any matter in which there is no unanimity of opinion among all the Trustees, the decision of the majority shall prevail in case if there are more than two trustees and if there are only two Trustees than their unanimous decision shall be necessary.

APPLICATION OF FUNDS:

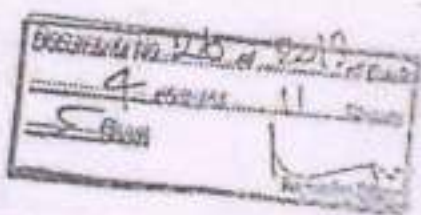

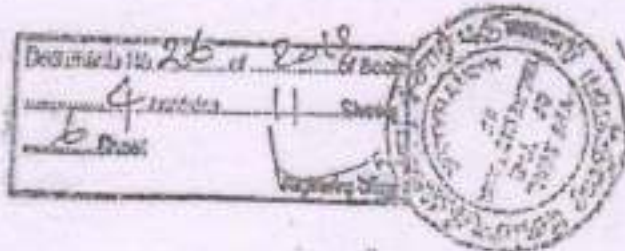
